Monash/C2Zero Real Carbon Price Index

The Monash/C2Zero Real Carbon Price Index (RCPI) provides a weighted composite measure of the physical price of carbon¹ across all jurisdictions based on mandated carbon prices set by regulators and governments.


The RCPI covers national, subnational and regional jurisdictions implementing a carbon tax or carbon emissions trading schemes (ETS) ²and jurisdictions with no mandatory carbon price – the latter being counted in the index using a price of zero.

The RCPI enables an overall global carbon price and price history to be determined, reflecting the global value of carbon.

The RCPI started in April 2013, covering 20 jurisdictions, accounting for 7.88% of global GHG emissions. As of May 2023, it covered 58 jurisdictions, accounting for 22.5% of global GHG emissions.

Highlights

- Last month, global carbon prices continued their downward trend, settling at -5.69%.
- The European Union Allowances (EUAs)
 concluded the month at its four-month low since
 January (USD 84.66/tonne). However, the bearish
 trend seems to bottom out as most fuel
 switching is done, and investors have reached
 record-high short positions.
- The Korea ETS made a recovery of 6.9% compared to the previous month's loss, as discussions about lifting the current limit on offset utilization for ETS compliance were ongoing.
- The upward trends in the Korean ETS and the China National ETS helped counterbalance the negative impact of the EU ETS on global carbon prices to some extent.




